- 1. The minutes of the 11th AGM held on 27 September 2007 were accepted as a true record without amendment.
- 2. Jeff had obtained prices and details of new nets from the same supplier that had been used for the court screens. The recommended net was quad stitched 3.55mm braided with a canvas / polyester headband which will cost £99 (excluding VAT although the VAT will be recoverable by the Parish Council). It was agreed that the purchase of this net should proceed and Jeff was requested to make JPK these arrangements.
- 3. The court sweeping rota was considered. John Lince volunteered to sweep the court on the next JL weekend, and it was agreed that this would be sufficient until the spring when this could be revisited.

It was proposed and agreed that these should remain at the same levels, (although it was noted that they had stayed the same for the last 11 years!). The club's finances remained healthy with a bank balance of almost £5,000, even after the resurfacing had been effected in the last year.
