- 1. Apologies received from Nick Whitehead.
- 2. The minutes of the last committee meeting held on 9 January 2024 were accepted as a true record except for a correction to the date of the next meeting which should have been stated as 5th March and not 5th January, (even though it was subsequently changed after the meeting as scheduled for 12th March).
- 3. The condition of the court currently was felt to be quite good, except for a proliferation of moss as a result of the wet weather. As soon as there was an opportunity (with some dry weather) Will and Mark will arrange to effect a moss treatment.
- 4. The condition of the net was considered to be acceptable, so no action was considered necessary until it showed some signs of deterioration.
